### RAFFLE RULES AND REGULATIONS

1. This raffle is conducted by Red River Events, Inc (dba 8750' Barbecue and Music Festival, Aspencade Music and Arts Festival), a New Mexico non-profit. All proceeds will benefit the Red River Valley Charter School.
2. The raffle will be conducted from July 20, 2023 to August 19, 2023.
3. One entry will cost \$25 or 5 entries may be purchased for \$100. The odds of winning are depending on the number of valid entries.
4. Purchasers of physical tickets must legibly write their name, address, phone number and email address on the ticket.
5. Online purchasers of tickets must provide the same information and this information will be transcribed onto physical tickets to enter the hopper.
6. If more than one name is listed on the ticket, the first name shall be considered the "entrant." Red River Events, Inc Shall, will, and can have no obligation for delivery of any prize to any person other than the entrant.
7. Minors may not purchase or have their names identified as entrants. Raffle is only open to U.S. residents.
8. Participants need not be present to win.

If the name of more than one person is submitted with a ticket purchase, and that ticket is selected as a winning ticket, then the person named first will be deemed the holder of record of that ticket and declared the winner. Division of prize by a group purchasing a ticket in common shall be to the sole responsibility of the person named as the holder of

record of that ticket, should that ticket be selected as a winner. Red River Events, Inc reserves the right to reject any entry form that is submitted with payment that does not constitute "good funds". All defective or physically altered entry forms will be immediately disqualified. Tickets cannot be purchased on the 8750festival.com website or by email. Any entry form submitted by email will be rejected. Red River Events, Inc reserves the right to reject any entry form that is submitted with payment that does not constitute "good funds".
